

Privacy Policy

The Royal Galapagos privacy policies outline the type of personal information to be gathered from our active users, as well as a notion of how the information will be used, with whom it can be shared, as well as the rights that the users have over their own rights and the security measures we use to maintain all of the data stored in our servers secure.

The gathering of the information is carried out by one, or more of the following means that are utilized by the company for this purpose, such as website questionnaires and/or forms, online systems, e-mails, phone calls, or any other type of chatroom discussion.

All of the information collected by Royal Galapagos will only be used for the purposes stated and not for any other. The Privacy Policy is subject to change without prior notice and for any reason as deemed necessary by the Company. Any change or update will be notified and communicated via your account manager.

What personal data do We collect or receive?

We obtain certain personal information in connection with the services we provide. The types of personal information we obtain include:

- Contact information, such as name, postal address, email address and telephone number;
- Payment information, such as name, billing address and payment card details (including card number, expiration date, and security code);
- Booking information;

This information is collected and stored once the agency or user decides to make a reservation either online, by telephone or through any other means. The data collected for credit / debit card payments are deleted after confirming the transaction and your reservation is ready.

Both the credit card holder and the members of the group must understand how the information is to be used and must grant their consent for such usage.

We may need to request information regarding your physical health if your trip is considered to be physically demanding or if you need special access or care due to a disability.

Purpose of information

Personal information collected will allow us to process the corresponding request for services as stated by the passenger or the Travel Agency.

The information might also be used for communication purposes and as a source of mailing lists used for mailing offers and newsletters regarding promotional travel packages and news articles about Ecuador and the Galapagos Islands. Aside to Comply with all services "requested and confirmed by the user".


Additionally, this information may also be used for the following::
